- To appoint a SPOC from Institute to coordinate & facilitate the program delivery
- To provide the necessary infrastructure for the training- Classroom space, Laptops/Desktops, Projector, Internet Connection

Duties and obligations of Sambhav: -

B. To conduct classroom training at Manghanmal Udharam College of Commerce.
